## PROGRAM OVERVIEW & THE ADVANTAGES

- » The Philanthropic Investment in Arkansas Kids Program allows nonprofit scholarship-granting organizations like ACE to raise scholarship money and help students statewide.
- » At least 90% of every gift goes directly to student scholarships, so contributors can feel confident their dollars are making a real difference for children, in addition to earning significant tax benefits!
- » Donors can reduce or eliminate their Arkansas state tax liability.

## STUDENT ELIGIBILITY

- » Families with incomes below 200% of federal poverty guidelines (~\$55,000 for a family of 4) are eligible.
- » Additionally, students attending an Arkansas public school or starting school for the first time in the state are eligible.

## WHO IS ACE?

- » ACE Scholarships is a 501(c)(3) charitable organization with an over 20-year track record of success in 10 states across the country.
- » Since starting in Arkansas in 2018, ACE Scholarships has awarded over 3,300 scholarships totaling over \$8.1 million worth of investments in students throughout the state.
- » By helping students attend ACE partner schools, you are helping keep the Arkansas K-12 private education sector strong and allowing these schools to reach more kids each year.

- » Your gift is eligible for a tax credit in 2023 until midnight on December 31, 2023. Checks dated January 1, 2024, or later will qualify for a 2024 tax credit.
- » Once approved, you will receive further instructions and documentation from ACE on how to claim the credit amount on your tax returns.
